

KELCHNER FOOD PRODUCTS OFFICIAL GIVEAWAY RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Eligibility: This Campaign is open only to those who sign up at the Kelchner Food Products Facebook Post Giveaway and who are 18 years of age or older as of the date of entry.
